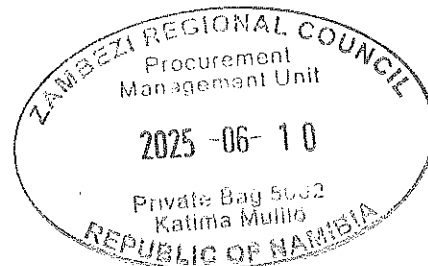

### 1. Rights of Public Entity

The **Directorate of Education, Arts and Culture (Zambezi Regional Council)** reserves the right:
