1. GENERAL

Bids were called for the construction of a Large Ablution Block and Septic Tank for Kongola Combined School for the Directorate of Education, Innovation, Youth, Sports, Arts and Culture in the Zambezi Region. The closing date was on the 13th March 2026 at 10H00 (Bid opening report attached).
